CHILD PROTECTION STATEMENT FOR JUDGES AND OFFICIALS

To become a Judge, Show Official (steward, volunteer) or Director for Senior Showing and Dressage Ltd, all personnel must comply with the following requirements:

At the point of application to become a Judge, Show Official or Council Member for SSADL or renewal of an existing membership, you must disclose whether you have any convictions, cautions or outstanding matters, that would prohibit or make you unsuitable to be in the proximity of children or vulnerable adults. This would also include any criminal convictions that would otherwise be classed as "spent" under the Rehabilitation of Offenders Act 1974.

- SSADL takes its responsibilities very seriously and requires all its directors, judges and officials who appear in the SSADL Rule Book, to voluntarily disclose whether they have any of the above?
- Child protection is defined in the Children's Act 1989 and all legislation is in place to protect children and vulnerable persons from any significant harm, abuse, neglect or exploitation this being physical, sexual, emotional or verbal abuse.
- SSADL takes its responsibilities to ensure that all vulnerable people competing within its society are safe and protected.
- It is acknowledged that when children or vulnerable people compete within the SSADL series. This is done so within the public domain and safeguards need to be put into place.
- In all circumstance's parents remain accountable and responsible for the safety of their children and their actions towards other people's children or vulnerable adults within their care.
- This declaration gives SSADL the authority to request an Enhanced Disclosure & Baring Certificate on any individual where any concerns are raised and allows SSADL to ban and remove anyone who they deem to be unsuitable from membership of SSADL.
- It is everyone's responsibility of all personnel to report any actions if they believe, any child or vulnerable adult is being subjected to any form of abuse. SSADL will immediately report these matters to the Police and relevant child protection agencies.
- This is a voluntary arrangement designed to affect a safe environment for children and vulnerable adults to be able to show and take part in any SSADL equine events. Information of this nature will not and cannot be kept confidential, as the safety of the vulnerable person is paramount.
